# MINUTES OF THE 4<sup>th</sup> MEETING OF THE WETLAND AUTHORITY OF DELHI, GNCTD CONVENED BY CHIEF SECRETARY, DELHI ON 28.01.2021 AT 4.30 PM.

As a prelude, Chief Secretary, Delhi was updated on the status of Wetland Authority by Addl. Chief Secretary (Env.). MS (Wetland Authority) made a PPT Presentation on the actions taken and agenda for discussion. Following decisions were taken:-

#### 1. ATR on previous agenda items:

## (a) Tikri Khurd Lake:

Chief Secretary, Delhi directed the representative of DDA to remove the encroachment in Tikri Khurd village. The representative of DDA responded stating that the said land encroached upon, is part of an unauthorized colony and not under the jurisdiction of DDA. Chief Secretary, Delhi directed that the status of land around the waterbody in Tikri Khurd is to be inspected within one week by DDA and District Authorities and action initiated for removal of encroachments.

### (b) Najafgarh Jheel:

MS (Wetland Authority) informed that EMP has been submitted to CPCB as per Hon'ble NGT's order. However, District Authorities were requested to submit the ownership details including Khasra numbers involved in the Jheel. DM (South-West) submitted that the information will be provided within a week.

## 2. Receipt of information on Waterbodies:

Information pertaining to action plans and brief documents were discussed and Chief Secretary, Delhi directed representative of GSDL and concerned land owning agencies, to complete geo-tagging of all the remaining waterbodies within one month.

MS (Wetland Authority) informed that during the pandemic period, handholding workshops on preparation of brief documents and action plans on conservation of wetlands were organized by Wetland Authority, the same has also been uploaded in You-Tube for the benefit of waterbody owning agencies.

Chief Secretary, Delhi expressed his displeasure on the pendency of DDA on submission of information in the prescribed format of action plans and brief documents and directed that the information be invariably submitted by 28.02.2021.

Chief Secretary directed that action plans and brief documents of all remaining wetlands shall be submitted by concerned water body owning agencies within 28.02.2021.

#### 3. Restoration/creation of Pond in every Village:

Chief Secretary, Delhi with regard to Model Pond (restoration and creation of pond) and meetings with all stakeholders in every village, directed all the District Magistrates to comply with the directions of Hon'ble NGT and to complete all required steps within a time bound manner and report be submitted on or before 31.03.2021.

The representative of INTACH queried about the parameters of the Model Pond, to which Chief Secretary, Delhi desired that the bench mark for Model Pond be suggested by INTACH, which was agreed to and it was informed that the same will be mailed to Wetland Authority after consultation with Dr. Ritesh Kumar, Director, Wetland International South Asia.

Meeting ended with thanks to the Chair.
