1. Hauz Khas:-

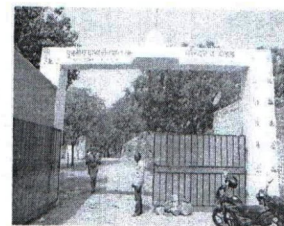

It belongs to DDA. Concerned officers/officials were not present at the time of inspection so the inspection is not completed. Sh. M.A. Baig, Assistant Engineer, SW2 (Other region) from DDA present at the inspection and was not able to identify the site. Court Commissioner directed that explanation may be sought from DDA for absence.

2. Mehrauli:-

G. No. Kh. No. 109 (21-8)

It is dry. Dispute over ownership of the said water body. SDM (Mehrauli) was present at the time of inspection and issued direction to Tehsildar (Mehrauli) to clear the ownership within 15 days. If the ownership is not clear then the land of water body will be handed over to BDO and remove the encroachment. Action taken report may be submitted to the Court Commissioner.

It is dry water body of DDA. Sh. M.A. Baig, Assistant Engineer, SW2 from DDA indicated that this water body is falls under him. He is unable to identify the area of this water body. There are workshop are running inside. There are some jhuggis also. Mandir has also been exists and remaining land is in shabby condition and Sh. Baig said that this is a water body. Let him report him report for what he has done before. The two site plan shown to Court Commissioner. One with green marking and one in red marking. However, in both the site plan water body is not mentioned. Sh. Baig is here for last 8 months and he is directed to produce all communication alongwith the file movement since he has taken over. The file be produced on 20.4.2015 in the chamber of Court Commissioner.

No. of the water body but as per revenue record of BDO it is reflected as Kh. No. 170/2 for the same water body. BDO (South) to clarify the above Kh. No. of the water body and the reply to be submitted in Hon'ble NGT.
