ORDER

In pursuance of Rule 5 (6) (b) of Wetlands (Conservation and Management) Rules, 2017 issued by Government of India, a "Grievance Committee" under Wetland Authority of Delhi is hereby constituted as a mechanism for hearing and forwarding the grievances raised by the public to the Wetland Authority on wetlands falling under their respective jurisdiction, with the following members:-

1.	District Magistrate of respective District	Chairman
2.	Representative from Delhi Jal Board, of the concerned area	Member
3.	Representative from Irrigation and Flood Control Department of concerned area	Member
4.	Representative of concerned Water body owning agency	Convener

The terms of reference of the Grievance Committee, besides the directions/guidelines given by the Wetland Authority of Delhi, from time to time, will be:

- 1. To redress the grievances at the local level and recommend to the Authority for the finality of decisions.
- 2. The meeting of this Committee for the cases referred to by the Wetland Authority shall be held at least once every quarter or earlier so as to comply with time limit or other guidelines, and proceedings be presented in meetings of the Wetland Authority.
- 3. The Committee should consider matters as per the provisions contained in the Wetlands (Conservation and Management) Rules, 2017, as amended from time to time.

The Committee shall meet at least once in every quarter to perform their functions.

This issues with the approval of Hon'ble Minister, Environment and Forest.
