Prior to field inspection, the Court Commissioner called a meeting in his Ch. No. 404, Delhi High Court of various agencies on 28-05-2014, 29-05-2014 & 30.05.2014 in r/o Water Bodies. Visits of Distt. South, South East, North, North West, South West & New Delhi were conducted on 04.06.2014, 05.06.2014 and 06.06.2014. After the meetings, list of villages was issued to all concerned agencies. On the basis of field inspection of water bodies conducted on various dates, the detailed report of Distt. wise inspection of water bodies is submitted as follows:-

DISTRICT – SOUTH & SOUTH EAST

DATE OF VISIT: 04-06-2014

1. Jiya Sarai:-

Kh. No. 74.

Khasra No. 74 is fully built up means encroached. Representatives from Delhi Wakf Board were present at the time of inspection. According to Delhi Wakf Board the land not belongs to them. They have not issued any notification. They are only user department. Court Commissioner directed the SDMC and revenue officials to submit action taken report within one week. Exactly four months have passed but no inspection has been carried out as directed by Court Commissioner.



2. Jiya Sarai:-

IIT Lake.

No representative was present from IIT at the time of inspection. AE from SDMC told that this land was awarded to IIT vide award no. 295/60.

3. **Lado Sarai:-**

Kh. No. 37.

It belongs to DDA. The area is covered by T.B. Hospital as per the statement given by DDA representative.

4. **Lado Sarai:-**

Kh. No. 206 (4-19).

It belongs to DDA. It is fully encroached. Built up. No one from the Revenue Deptt. were present. Some part of this land was built up as a Community Center, Water reservoir of Delhi Jal Board and park exist. Some area is covered by private houses as per representative present from DDA. Court Commissioner directed that the entire area to be demarcated and report to be submitted alongwith site plan within one week. Sh. Prahlad Meena, JE from SDMC was present but unable to identify the site about the Community Centre.

5. **Lado Sarai:-**

Kh. No. 208.

It belongs to DDA. None of the officials from Revenue Deptt. were present. Representatives from DDA stated that Khasra No. 208 is not a water body.

6. **Lado Sarai:-**

Kh. No. 248.

It belongs to DDA. Representatives from DDA were not able to identify the site. As per the statement given by DDA officer, the water body is situated somewhere in the Golf Course. Court Commissioner directed DDA to get the area inspected and submit the action taken report within one week and also sought the explanation of revenue official's absence.



7. **Lado Sarai:-**

Kh. No. 335.

It belongs to DDA. The total area is (15-19) in which (11-19) land was awarded to other agencies and the remaining part of the land is unawarded. This is totally hilly area and is not a water body.

8. **Ladha Sarai:-**

Kh. No. 3(8-13) & 14 min (5-9) Total area (14-2).

It belongs to DDA. The officials present from revenue deptt. were not clear about the site. Court Commissioner directed the revenue deptt. to get the entire area demarcated by TSM and submit the status report alongwith photographs within a week.

9. **Mehrauli:-**

Kh. No. 109.

Representatives present from DDA and CPWD stated that this land does not fall in their jurisdiction. This land is dry. Temple exists there. Land is covered by boundary wall. Some jhuggis are exists there on rental basis. Plantation could be done. Court Commissioner directed that SDM shall take over and protect the land which is being encroached by various persons. Removal action shall immediately be taken and catchment area should be reconstructed. Action taken report should be submitted within one week.

Kh. No. 1166 (1-16).

It belongs to DDA. Stay order by Saket Court in favour of farmers Baljit Singh and Ranbir Singh.

11. **Mehrauli:-**

Kh. No. 1219 (4-19) & 1220 (13-3).

It belongs to DDA. Encroachment in the form of School.

12. **Mehrauli:-**

Kh. No. 537 (2-10).

It belongs to DDA. This is fully built up.

13. **Mehrauli:-**

Kh. No. 119.

It belongs to DDA. It has boundary wall. Court Commissioner directed DDA to get the area demarcated and submit the status report within one week.

14. **Fateh Pur Beri:-**

Kh. No. 1187 (8-4).

It belongs to BDO. It has dirty water. Villagers were found dumping at the water body. Demarcation has been done. Garbage were found in and around the water body. As per record the land is thok gujran shamlat. This is a gairmumkin johar. Court Commissioner directed the concerned revenue staff to demarcate the area by TSM and submit the action taken report by 17.6.2014. In this regard, a meeting shall be convened in the chamber of Court Commissioner at Delhi High Court on 26.6.2014 at 2:00 PM. I&FC, BDO and Revenue Deptt. to attend the meeting.

15. Fateh Pur Beri:-

Kh. No. 1265.

It belongs to BDO. This is a land locked water body. Court Commissioner directed the concerned revenue staff to demarcate the area by TSM and submit the action taken report by 17.6.2014.
