Distt. - East:-

1. Chandrawli shahdarra: -

It belongs to DDA. CEO, DPGS directed that this water body area to be inspected by the Court Commissioner. It is near to Babu Ram School.

2. Chilla saroda khaddar: -

It belongs to BDO. CEO, DPGS directed that this water body area to be protected and get inspected by BDO and concerned HA. It falls in the river belt near Chilla.

3. Chilla saroda Banger: -

It belongs to DDA. It is nearby Mayur Place. CEO, DPGS directed BDO staff and concerned HA to find out this place and get the area inspected.

4. Dallu pura (15900 sq. mtr. (a) to(d) Khasra no. 171 to 175 min):-

It belongs to DDA. Near Agarsen College. BDO staff informed that the land has been allotted to various agencies. It has been discussed that this land to be inspected by the Court Commissioner. DDA to prepare the action plan for plantation in the vacant land.

5. Gharoli (7) (a) to (d) and (e) to (g):- (a) to (d) 13380 sq. mtrs. (e) to (g) 1002 sq. mtrs. K. No. 947/672:-

It belongs to DDA. CEO, DPGS directed that the entire area to be protected through tree plantation. BDO staff are directed to get the inspection done through Court Commissioner. TSM survey required.

6. Gharonda neemka khaddar: -

It belongs to BDO. BDO staff informed in the meeting that this area is nearby Samachar Apartment, Alhcon Public School in village Patparganj.

7. Gharonda neemka nangar: -

It belongs to DDA. As per the discussion held in the meeting, Ghronda neemka nanger is not exists.

8. Gharoda neemka bhangar (64(2-5): -

It belongs to DDA. Bapu Nature Hospital. BDO informed that there is no space left for plantation.

9. Ghazipur (15000 sq. mtrs. K No. 487): -

It belongs to DDA. CEO, DPGS directed that this area to be protected. Bus stand is built up. Encroachment is exits there.

10. Ghazipur (6620 sq. mtrs. Kh. No. 519):-

It belongs to DDA. Land allotted to Delhi Agriculture Marketing Board. Direction has been given to DDA to get the tree plantation done on the vacant land.

11. Ghazipur (6200 sq. mtrs.):-

It belongs to DDA. CEO, DPGS directed the DDA to get the tree plantation done.

12. Ghazipur (464(0-09):-

It belongs to MCD. To developed MCD park. Direction has been given for tree plantation.

13. Ghazipur (207 (2-15):-

It belongs to DDA. Tree plantation to be done in park by DDA. According to GSDL this water body is not located in Kh. No. 207. It is found in Kh. 209 which is nearby.

14. Ghazipur (579 (4-10):-

It belongs to DDA. It has to be protected and inspected by DDA alongwith concerned Horticulture Assistant. Tree plantation to be done by DDA.

15. Hasanpur F/74:-

It belongs to DDA. Low lying area. It has to be protected and inspected by DDA alongwith concerned Horticulture Assistant.

16. Kondli (a) 471/1 29(1-4):-

It belongs to DJB. Kh. No. 471/129(1-4) and Kh. No. 628/219 (3-0) are together. Delhi Jal Board staff quarters and STP plant. Tree plantation to be done at the vacant land. Inspection to be done by the concerned Hort. Assistant.

17. Kondli (b) 628/219 (3-0):-

It belongs to DJB. Same as above.

18. Kotla shahdara:-

It belongs to DDA. This land is in front of Mayur Vihar phase-II. Green Belt has been developed by DDA.

19. Kaithwara F/66:-

It belongs to DDA. MCD storm water plant exists. River belt.

20. Karkarduma F/74(2) (a) 1600 sq.mtr. Kno. 560 min:-

It belongs to DDA. Ambedkar park has been developed by Delhi Jal Board. Near petrol pump. CEO, DPGS directed to get the tree plantation done.

21. Karkarduma F/74(2) (b) 3500 sq.mtr. K No. 483 to 492):-

It belongs to DDA. Commercial centre has been developed by DDA.

22. Khichripur F/74 (a) Kh. No 360 (1875 sq. mtrs.):-

It belongs to DDA. Encroachment by villagers. The site to be inspected by the Court Commissioner.

23. Khichripur F/74 (b) 1500 sq. mtrs KNo. 587/702 & 587/316 (55 acres Samriti Van):-

It belongs to DDA. DDA staff informed that metro work will be start soon.

24. Khichripur F/74 (c) (1000 sq. mtrs.):-

It belongs to DDA. Near Sanjay Lake. Tree plantation to be done.

25. Khureji Khas F/74 (a)5/10 (1-18):-

It belongs to DDA. Heavy built up. CEO, DPGS directed to develop water harvesting system. Delhi Jal Board to initiate necessary action in this regard.

26. Khureji Khas F/74 (b) 25/31 (2-0):-

It belongs to DDA. Encroachment exists.

27. Khureji Khas F/74 (c)26/29(4-2):-

It belongs to DDA. Encroachment exists.

28. Kotla F/8963 (2-0:-

It belongs to DDA. In front of Sanjay Jheel. Park. More and more trees to be planted.

29. Mandawali fazilpur (a) 625, 626 (30-0):-

It belongs to MCD. G.No. 29 and 47 are same. To be corrected. Low lying area. School exists on one side. CEO, DPGS directed that more and more trees species to be planted and Rain water harvesting system to be developed.

30. Mandawali fazilpur (b)116(1-1):-

It belongs to DDA. Green area already developed. Inspected to be done.

31. Mandawali fazilpur (c) 123min(16-7):-

It belongs to DDA.

32. Mandawali fazilpur (d)651(1-4):-

It belongs to DDA. Heavy built up. Can be green to some extent.

33. Saleempura:-

It belongs to BDO. G. No. 33 and 96 are same. Saleempura does not exists.

34. Samaspur Jahagir:-

It belongs to DDA. At Noida more. Opposite petrol pump. Near Delhi Police Society, Mayur Vihar Phase-I. DDA to provide Kh. No. and area of this land.

35. Seema puri:-

It belongs to DDA. No record has been provided by the DDA.

36. Shakarpur baramad:-

It belongs to DDA. There is a water body. GSDL mark the water body at Kh. No. 0/6/1.

37. Shahdara F/74

It belongs to DDA. To be inspected by Court Commissioner.

38. Shakarpur Khas F/74 (a) Kh. No. - 20(1-7)

It belongs to DDA. Heavy built up. Near Lalitha park.

39. Shakarpur Khas F/74 (b) Kh. No. 146 min (8-13)

It belongs to DDA. Park already developed. Near DDA and DESU office. Tree plantation needs to be done.

40. Shakarpur Khas F/74 (c) Kh. No. 155 (1-04):-

It belongs to DDA. Park already developed. Tree plantation needs to be done.

41. Shakarpur Khas F/74 (d) Kh. No. 159 (0-15):-

It belongs to DDA. Encroachment exists. Inspection to be done.

42. Shakarpur Khas F/74 (e) Kh. No. 173 (0-12):-

It belongs to DDA. Park. Can be green. Inspection to be done.

43. Shakarpur Khas F/74 (f) Kh. No. 184 (0-15):-

It belongs to DDA. Partly green.

44. NH-24 I.P. Extension (a) 20000 sq. mtrs. Khasra no. 513:-

It belongs to DDA. This area to be protected and developed as green. Kh. No. to be provided by DDA.

45. Sanjay Lake (a) 170000 sq. mtrs. (17 ha)

It belongs to DDA. Already developed.

46. Vinod Nagar (a) 6600 sq. mtrs. K No. 882 to 885:-

It belongs to DDA. Entire area to be protected. To be developed as green. Near about Sanjay Lake.

47. Vinod Nagar (b) 34000 sq. mtrs. K No. 625 MCD Park

It belongs to MCD. G.No. 29 and 47 are same.

48. Vinod Nagar (c) 3.5 hectares:-

It belongs to DDA. This area to be inspected by the Court Commissioner.

49. Shastri Park (a) 1000 sq. mtrs. Khasra no. 109:-

It belongs to DDA. Agriculture field. In river belt.

50. Shastri Park (b):-

It belongs to DDA. Coat market exists there.

51. Nand Nagari (2) Mandoli (a) 34027 sq. mtrs. K No.911, 912:-

It belongs to DDA. It can be green. Entire area to be protected. DDA has to prepare an action for greenery.

52. Nand Nagari (2) Mandoli (b)

It belongs to DDA. The water body is next to the jail. DDA to provide Kh. No.

53. Sunder Nagari (a) 1500 sq. mtrs:-

It belongs to DDA. Park. Can be green. Inspection to be done.

Distt. – North East:-

54. Babar pur (a) 14(2-9):-

It belongs to BDO. Shamshan Ghat exist on the water body. Greening to be made.

55. Babar pur (b)13 min (01-0):-

It belongs to DDA. Inspection to be done by DDA and submit the report.

56. Babar pur (c) 137 min (3-5):-

It belongs to BDO. As per the report of BDO North East that the water body has been developed. Re demarcation of the area of water body is under process. In this regard a letter reminder dated 5.7.2013 written by BDO (North East) to SDM Shahdara. Direction has been given to BDO to take necessary action on priority basis.

57. Badar pur khaddar

It belongs to BDO. Inspection to be done by the Court Commissioner. According to BDO report there is no water body as per revenue record.

58. Baqiabad

It belongs to BDO. Near Badarpur Khaddar. Inspection to be done by the Court Commissioner. According to BDO report there is no water body as per revenue record.

59. Biharipur

It belongs to DDA. GSDL mark the water body at Kh. No. 508. Adjoining Police Training Centre. DDA has to protect the water body. According to BDO report there is no water body as per revenue record.

60. Ghonda Gujran banger (a)1 etc/136(10-19):-

It belongs to DDA. Already developed park. Near Mother Dairy Booth. DDA has to inspect the site alongwith concerned HA.

61. Ghonda Gujran banger (b) 1 etc/139(3-3):-

It belongs to BDO. Green area. To be developed as green area. BDO staff has to inspect the site alongwith concerned HA.

62. Ghonda Gujran banger (c) 5 (0-12):-

It belongs to DJB. CEO, DPGS directed that the area to maintained as green.

63. Ghonda Gujran banger (d) 6 (6-15):-

It belongs to DJB. CEO, DPGS directed that the area to maintained as green.

64. Ghonda chauhan khaddar:-

It belongs to DDA. Near Buland Masjid. GSDL mark the water body at Kh. No. 130. CEO, DPGS directed to DDA that this area to be protected by making board and tree plantation. According to BDO report there is no water body as per revenue record.

65. Ghonda gujran khaddar:-

It belongs to DDA. Near Petrol Pump. Cleaning. Garbage should be removed. DDA has to inspect the area alongwith concerned HA. According to BDO report there is no water body as per revenue record.

66. Gokulpur (a) 300/1 (2-4)

It belongs to BDO. Completely developed by plants. As per the report of BDO North East that the MCD Deptt. will remove the garbage from the water body and I&FC Deptt. will arrange for flow of water into water body. In this regard a letter dt. 7.1.13 has been written by BDO (N/E) to MCD and also request to I&FC Deptt. to prepare plan for increasing the catchment area of the water body.

67. Gokulpur (b) 656(0-18)

It belongs to BDO. Heavy built up. According to the report of BDO (N/E) demarcation has been done by TSM by Consultant/Engineer and demarcation map provided by him on dt. 30.10.2012 to this office. As per map in both Kh. No. 656 and 657, twenty two (22) properties has been found in the shape of heavy built up, which is a part of unauthorized colony and is under process for regularisation by Delhi Govt.

68. Gokulpur (c) 657 (012)

It belongs to BDO. Same as above

69. Garhi mandoo

It belongs to Forest Deptt. This water body is in juricdiction of Forest Deptt. Platation already done. Partly encroached. According to BDO report there is no water body as per revenue record.

70. Ghonda F/74

It belongs to DDA. Not clear.

71. Ghonda neemka F/89

It belongs to DDA. Not clear.

72. Jafarbad

It belongs to BDO. Park exists. CEO, DPGS directed the BDO staff to get the area inspected alongwith concerned HA. According to BDO report there is no water body as per the revenue record.

73. Jeevenpur Johripur (a)6/16/2 (1-5):-

It belongs to BDO. Shamshan Ghat exist on the water body. Greenery to be made.

It belongs to BDO. Around 3.17 area has been alloted to DTC and 0.19 area has been encroached by villagers. Direction has been given for inspection by BDO Staff.

80. Khajuri khas

It belongs to BDO. Built up. Direction has been given to BDO staff for Inspection.

81. Khanpur dhani:-

It belongs to DDA. New Mustafabad. Partly encroached. Small Park. Greenery to be developed. According to BDO report there is no water body as per revenue record.

82. Mandoli:-

It belongs to BDO. Near Cargo Steel Company. Direction has been given to BDO staff to get the area inspected and submit the report in the next meeting. According to BDO report there is no water body as per revenue record.

83. Mirpur turk:-

It belongs to BDO. River Belt. Near Sonia Vihar. Inspection to be done. According to BDO report there is no water body as per revenue record.
