### MINUTES OF MEETING OF INSPECTION (DISTRICT East & North East) HELD ON 02.06.2018 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

#### 1. Ghonda Chauhan Banger

##### (a) Khasra No. 1 etc/139 (3-3)

At present Delhi Jal Board SPS is functioning at the site of water body.



**(b) Khasra No. 1 etc/136 (10-19)**

It was found that sewage was flowing into the storm water drain. EDMC to prepare the plain so that sewage does not flow into the storm water drain rather should be directed to SPS installed nearby. The storm water should carry only the rain water which also could be diverted into water body. The rainy season is on the corner as such EDMC should speed up with their action plan. Report/action plan should be submitted within 15 days.





**(c) Khasra No. 5 (0-12) and 6 (6-15)**

It belongs to DDA. On part of land SPS-I of Delhi Jal Board is functioning at the site. It is situated opposite dispensary and Adjoining Krishna Park, which is being maintained by EDMC. They have been requested to prepare a plan for collecting the entire water into Krishna Park and prepare a harvesting plan (M-3). Harvesting system is running/maintained by DJB on the Water Body Area. However, an area of 2500 sq. yard is left out for which DJB will prepare a harvesting plan. DJB should also take into account the water on surface area.



**(2) West Vinod Nagar (Area – 34000 Sq. Meter)**

It belongs to DDA. EDMC to clean the entire garbage within 2 days and not to dump any further garbage. DDA will make all the efforts and get the water body cleaned within 15 days. EDMC and DDA to coordinate for getting the catchment of rain water.





**(3) West Vinod Nagar (Area – 6600 Sq. Meter)**

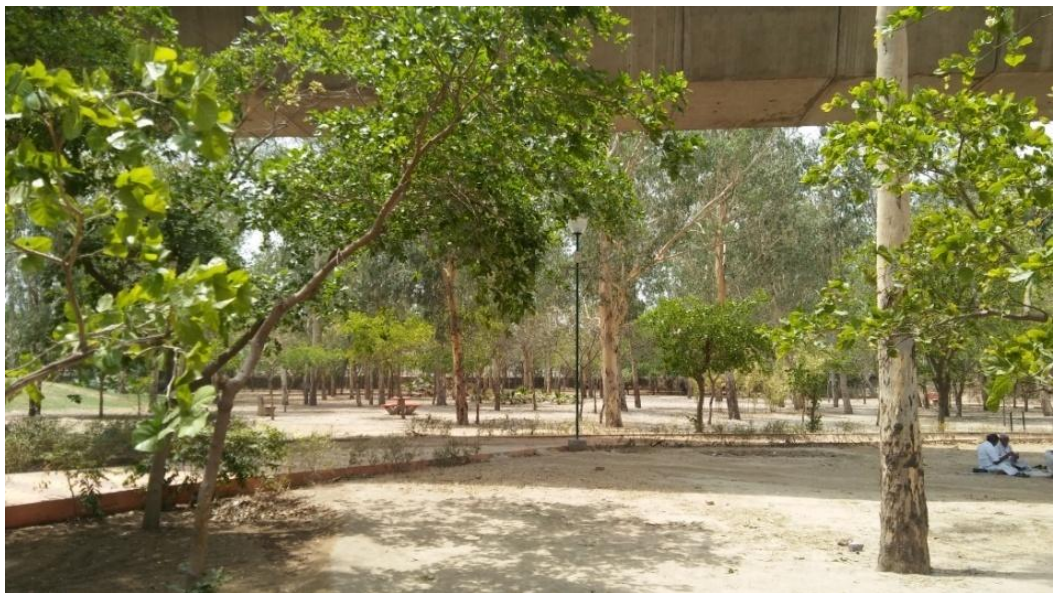
Although Water Body belongs to DDA but DDA Staff present during the inspection.

**(4) West Vinod Nagar (Area – 3.5 Hactare)**

Although Water Body belongs to DDA but DDA Staff present during the inspection.

**(5) NH-24 I.P. Extension (Area – 20000 Sq. Meters)**

Catchment to be provided of all the roads to the maximum. DDA to coordinate with PWD, NHAI and DMRC and fix a meeting to see how rain water can be diverted into this Water Body.





6. **Ghazipur**

**(a) Khasra No. 365 (14 bigha) Area - 6200 Sq. Meters**

Same position as per last visit. DDA assured that Entire garbage would be cleaned within 15 days. Walls for the protection of Water Body will be raised and repaired. Sign Boards would be installed. Chairs, Seating benches etc. be also placed and the area be made green. Residents may also be joined



**7. Sanjay Lake (Area - 170000 Square Meters (17 Hectare))**

It belongs to DDA. Chief Engineer (East Zone), DDA may fixed the demolition programme to remove the unauthorized encroachment from the Sanjay Lake opposite Kotla Village. During demolition programme SDM (Mayur Vihar) and concerned officers of EDMC will assist DDA.
