MINUTES OF MEETING OF SITE (DISTRICT WEST AND SOUTH-WEST)

INSPECTION HELD ON 05.06.2016 BY THE COMMITTEE APPOINTED BY

THE HON'BLE HIGH COURT

1. Madipur

(a) Khasra No. 1298 (23-02)

No one is present from DDA and Revenue Department and it is 9:20 am. It appears that they have deliberately decided not to be present today. Vice Chairman, DDA may be informed and explanation be called from defaulting officers/officials.

(a) Khasra No. 39//9/2 (05-08)

The Water Body is developed and is filled with Tube Well Water. The area of Water Body also includes temple.



(c) Khasra No. 165 (02-08)

Sh. Om Vir Singh, Panchayat Secretary has been shown the condition of the water body. He is directed to get the Malba removed within 7 days and further get the water body clean 7 days thereafter. Report be submitted by 30th June, 2017.



(d) Khasra No. 85//9min(01-16)

There is no approach road to the Water Body. No demarcation has been carried out till date. It is stated that the file have been moved for demarcation purposes and is at present before District Magistrate. SDM will report about the outcome of the same within 1 week. Next visit on 23.6.2017 and 24.6.2017.

(e) Khasra No. 91//22 (11-09)

It was reported that the land belonging to Johad has been attached. The authorities have to verify as to how and when the land belonging to Johar has been allotted. On the spot it is found that some land is lying vacant adjacent exchanged to the land of Johar. The authorities to look into the records and have the said land converted to Johar.



(f) Khasra No. 19//9 (13-06)

The Land (Johar) is locked. There is separate path by which one can reach the Johar. We travelled through some one's field to reach the Johard. The authorities should get a specified path to reach the Johad.



(g) Khasra No. 75//17 (09-04)

Relevant records were not available with the authorities. The authorities were requested to make available the entire record on Thursday 15th June, 2017 at 11.00 A.M. at East Patel Nagar office of the Court Commissioner.



(h) Khasra No. 162 (17-09)

It is Natural water body, however, water is filled up with tube well.



4. Surakh Pur

(a) Khasra No. 204 (04-06)

Although Water Body is developed but requires cleaning and maintenance. Further, no catchment was found for rain water. Steps should be taken immediately.



(b) Khasra No. 64 (07-04)

It is natural water body, however, water is filled up with tube well.
