MINUTES OF MEETING OF SITE INSPECTION HELD ON 06.06.2016 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

1. Bahapur (DDA)

(a) Khasra No. 630/2(18-09)

It is dry. No catchment for Rain/Extra Water was found. Catchment should be made. It was suggested if keekar trees could be removed, as Keekar Trees absorbs lot of water, instead Neem and other species could be planted.



(b) Khasra No. 53/2(01-12) (MCD)

There is huge Car Parking constructed by the MCD comprising of Basements (Two Levels) as informed by MCD. There is also a park at site which was more than (0-12) area. MCD was directed to keep the area green. It is also stated that water level in the area is available at 5 meter underneath.



2. Badar Pur (DDA)

(a) Khasra No. 24//20(04-16) & 24//21(04-00)

Many unauthorized Jhuggies were found at site. Further Water Body was full of Dirty Water. It was noticed Water body has been converted into dumping yard. The Water Body is located near to the main road and can fetch good amount of rain water from the Road. DDA to submit proposed Action Taken Plan within a month to the Court Commissioner.



3. Madangir (DDA)

(a) Khasra No. 191min (19-05)

Mandir, Community Centre exists in the park. At spot only around 1 Bigha of Water Body exists. Rest is all concrete. It is also stated that the total area of Khasra No. 191 is 29 Bigha out of which 10 Bighas is lying vacant. Directions were given to DDA to attend the meeting to be held at 31/26, East Patel Nagar, New Delhi-110008, office of Sh. V.K. Tandon, Court Commissioner (M) 9810177733 on 13.06.2017 at 11.00 AM alongwith entire records and Action Taken Plan.



4. Chirag Delhi

(a) Khasra No. 780/498(06-16)

MCD parking exist on the water body land. The name plate affixed on the Entrance Gate reads as "Chirag Dilli Chill Chill Johar". This land is also abutting the main road and can fetch good amount of water during rains. MCD to submit proposed Action Taken Plan within a month to the Court Commissioner.





5. Sheikh Sarai

(a) Khasra No. 122(03-09)

Revenue Department told that it has gone to Housing Department of DDA. However, the said officials could not locate/identify the Water Body. Apart from the above Water Body, Seikh Sarai has more number Water Bodies, as per revenue record. Directions were given to DDA to attend the meeting to be held at 31/26, East Patel Nagar, New Delhi-110008, office of Sh. V.K. Tandon, Court Commissioner (M) 9810177733 on 13.06.2017 at 11.00 AM alongwith entire records and Action Taken Plan.



6. Saidulajaib

(a) Khasra No. 200/2(01-13)

No one from DDA was present. Area is exactly between the village. It was onnly with the help of villagers, we could reach to the point. As per villagers buildings have been constructed on the Johar land. Further, as per villagers, all flow of water would automatically come over the Johar land and accordingly would be good place for re-charging of underground water. DDA should bring out the plan accordingly and also should take appropriate action for removal of encroachment.
