MINUTES OF MEETING OF INSPECTION (DISTRICT NEW DELHI) HELD ON 07.04.2018 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

1. Mohd. Pur Munirka

(a) Khasra No. 201/1 (00-05)

It belongs to DDA. Parking is found in part of the water body area and some part of it is playground. Rest of it is stated to be encroached. A Court Case is stated to be pending. Details of which shall be furnished within one week. It is further stated that this park and parking area is found at present was handed over by DDA (Hort.) to MCD (South), as per policy. The site which was handed over which was park at that time. MCD to furnish a status report as to under which provision/Law the site has been converted from green to parking.





(b) Khasra No. 705/2 (14-11)

It belongs to DDA. Sewage was found over flowing into the water body. Chief Engineer (South Zone), DDA assured to look into the matter and revert back within fortnight regarding the over flowing and blockage of sewage and also recharging of water body through catchment of rain water from nearby surroundings concerned with the Jal Board officer was not present. Delhi Jal Board to also look into the matter regarding the over flowing and blockage of sewage.



(c) Khasra No. 823/1 (2-10) & 823/2 (5-17)

It belongs to MCD. MCD will inform the status and plan with respect to catchment of rain water from the roads so that there is recharging of underground water.





2. Masoodpur

(a) Khasra no. 205 (40-6)

It belongs to DDA. Area is reported to be handed over to MCD (Hort.) in 2016. However the condition is pathetic as there is no ingress of water, as stated, from the roads to the water body. Nobody was able to explain as to why Water Body was in such pathetic condition and why there was no provision of catchment of rain water. The water body would be clean by within one week and report be submitted on 13.4.2018 at 2:00 PM in chamber of Court Commissioner at Chamber No. 404, Lawyer's Chambers, Delhi High Court, New Delhi – 110002.
