MINUTES OF MEETING OF INSPECTION (NEW DELHI AND SOUTH WEST DISTT.) HELD ON 11.06.2019 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

1. Mehrauli

(a) Khasra No. 109 (21-08)

It belongs to CPWD. Sh. V.K. Singh, Executive Engineer, CPWD has been shown various letters written by Land and Development Office (L&DO) regarding handing over the site for construction/maintenance of the water body. The site has also been fully shown to him. He has been requested to prepare plan alongwith action plan for а site construction/revival of water body. The needful be done within 15 days from today positively. Immediate action for construction/revival shall also be undertaken. It will be ensured that all catchment area be connected and unauthorize construction be removed. It will also be ensured that the water body is not filled up from bringing outside water through tanks or borewells and all endeavor should be made for filling of the water body through rain water and catchments. The report be submitted at office of Court Commissioner at 31/26, East Patel Nagar, New Delhi- 110008 latest by 25.06.2019.





2. Rajokri

(a) Khasra No. 1817 (1-18)

It belongs to Forest Deptt. After demolition Revenue Deptt. has handed over the possession of this water body to Forest Deptt. It is a natural Water Body. The Forest Deptt. should put up a board and protect the same.





3. Rajokri

(a) Khasra No. (1848 to 2160)

It belongs to Forest Deptt. After demarcation the land has been handed over to Forest Deptt. It is a natural water body. The area has to be developed as a natural water body as it is deep and shallow. There are various Khasra Numbers falling in this area. It is more than 40 acres of land and it is between two Mandir"s one of which is Baba Kholi Wala and other is Baba Dada Wala. In case the water is filled up during rainy season it will be a great source of recharge for the nearby villagers.





4. Bijwasan

(a) Khasra No. 168 (20-18)

It belongs to BDO. A channel has been constructed so that entire drain/rain water of the village seeps into this water body. Rough sketch may be provided. Next visit shall be fixed after rains.





6. Bamnoli

(a) Khasra No. 28/5 (04-06)

It belongs to DDA. Same position as per last visit. The Water Body is in Pathetic condition Only Boundary wall has been constructed. Sewage is flowing into the Water Body. Officers of MCD and DDA are not present. It is apparent that they are not present to frustrate our visit.





(b) Khasra No. 232 (04-14)

It belongs to DDA. Same position as per last visit. The Water Body is in Pathetic condition Only Boundary wall has been constructed. Sewage is flowing into the Water Body. Despite prior intimation Officers of MCD and DDA are not present. Malba was also found dumped in the Water Body. It is apparent that they are not present to frustrate our visit.





7. Dhaula Kuan

(a) Khasra No. 562/181 (Min) (5.89 Hectare) (15000 sq. mtrs.)

It belongs to DDA. NHAI states that drain has been prepared from both sides. One from Dhaula Kuan to Arjun Vihar around 300 meters stretch and the other from Airport side to Arjun Vihar around 200 meters, around 50 meters from Metro Station. The entire water will be accumulated at Arjun Vihar junction from where DDA has tendered pipeline of about 350 meters which will take the entire water to the water body/Lake. The entire

process would be completed within a maximum period of 3 months.

Hopefully things will progress this time and we see positive results.

DDA should consider making a path from Road to Water Body from the junction from where DDA will take the entire water to the water body/Lake
