MINUTES OF MEETING OF INSPECTION (CENTRAL AND WEST DISTT.) HELD ON 13.06.2019 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

1. Naini Lake

It belongs to MCD. RWA is lending their hand to MCD for its maintenance. At site various grievances were raised by RWA and residents including problems of rats, flowing of sewerage into the water body/ Lake; re starting of Boating etc etc. The representatives of MCD, DTTDC, DJB were requested to look into the grievances and solve them. **It was further decided to have a Meeting with all concerned at 404, Lawyer's Chambers, Block No.1, Delhi High Court, New Delhi – 110003 on 29th July, 2019 at 3 pm.**





2. Mukandpur

(a) Khasra No. 175 &179 (08-07)

It belongs to BDO. **The Water Body is in Pathetic condition.** It is unfortunate that despite notice none is present on behalf of I&FC and Delhi Jal Board. The committee was shown a Letter dated 29.04.2019, issued by I&FC department indicating that the work of Water Body is to be carried out/done by DJB. The said letter has been duly replied by BDO indicating that the sanction order dated 31.12.2018 has to be first accomplished by I&FC and it is only thereafter that it could be forwarded

to Delhi Jal Board for further action at their end. Copies of communications has been handed over by BDO to the Committee.

The authorities are requested to coordinate and finish the task at the earliest. BDO is requested to intimate I&FC about the concern of the Committee. **The parties/Departments are requested to attend the meeting on 31.07.2019 at 404, Lawyer's Chambers, Block No.1, Delhi High Court, New Delhi- 110002 at 3 pm.**



3. Burari

(a) Khasra No. 148 (15-17)

It belongs to BDO. Water body is in pathetic condition. Sh. Ram Avtar Tyagi, Resident of Burari met us and showed us the order of Division Bench of Hon'ble High Court dated 31.10.2013 passed in W.P (C) 4437 of 2013. He says that order dated 31.10.2013 till date not been complied with. He further informed that he has filed a contempt petition which is pending in Hon'ble High Court and the Next date of hearing is 08.08.2019. He has been requested to kindly provide us the copy of the contempt petition alongwith latest orders.

On the other hand BDO Sh. Vijay Kumar states that file for cancellation of allotment under consolidation scheme, is under process. 4. **Mundka (Shishu Wala Talab)**

(a) **Khasra No. 190/1 (09-00)**

It belongs to DDA. **We are informed that by notification the Village Mundka alongwith water body has now been transferred to DDA. The Water Body is in Pathetic condition.** It is unfortunate that despite notice none is present on behalf of DDA. We had received a call from one Mr Jasveer Singh that he has been deputed for today's survey. We had informed him that we have left Burari and are on our way towards Mundka . After reaching Mundka we waited for him. Then we made number of calls on his phone The First call was picked up wherein he replied that he is reaching in a minute however, as he did not reach further calls were made from different numbers, which were not picked up . Since our calls were not picked up we had no option but to proceed further.

5. Tikri Kalan

(a) Khasra No. 225, 226 (2-1)

Belongs to BDO. Park is existing at site. However, There is no catchment of rain water to the Water Body.

Feasibility of catchment of rain water should be worked out. Report be submitted to the court committee on **31.07.2019 at 404, Lawyer's Chambers, Block No.1, Delhi High Court, New Delhi- 110002 at 3 pm.**



(b) Khasra No. 485 (9-3)

It belongs to BDO. It is stated that demarcation is under process and would be completed by 25.06.2019. Report will be submitted within 2 days thereafter. After receipt of the demarcation BDO shall take demolition action within one week. BDO will also submit action plan for revival of the water body. BDO will also collaborate with Delhi Jal Board for removal of sewage and for stoppage of sewage going into the water body.

(c) Khasra No. 480 (10-07)

It belongs to BDO. we find that despite earlier directions, no catchment holes have been made till date so that rain water from the roads could seep into the water body. BDO assures that needful will be done within 7 days from today.

Construction of Mandir on Gram Sabha land is also found. No permission for the said construction could be shown by BDO staff. It is to be explain as to how this construction was allowed. Necessary action be taken by BDO in this regard.
