It belongs to PWD. It is permanent wet. Sewage is flowing into the water body. Surrounding area is very dirty. Direction were given to Delhi Jal Board by Court Commissioner to remove the sewage from the water body and to develop the catchment area. Nobody is present from PWD, MCD, Delhi Jal Board and Revenue Deptt. at the time of inspection. Engineer in Chief, PWD is directed to maintain the water body alongwith greenery around it by PWD, Director (Hort.)
