MINUTES OF MEETING OF INSPECTION (NORTH AND NORTH WEST DISTT.) HELD ON 16.02.2019 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

1. Khera Kalan

(a) Khasra No. 39/26 (18-16)

The water body belongs to BDO. It is reported that demarcation had already been carried out and the same is accepted by BDO. I&FC will submit an estimate within one week which shall be cleared by BDO within a week thereafter. Thereafter tenders will be floated and the entire work should be completed by June, 2019 itself. While the I&FC Department could start construction of boundary walls from one site, BDO in the meanwhile will take appropriate action for removing of the encroached area and make the water body encroached free. The same will be handed over to the Head of Department at the earliest so that the work is completed by June, 2019 as indicted above. Shri Sunil Kumar Verma, Extension Assistant, Revenue Department stated that clarification with regard to the encroachment, as sought for by Divisional Commissioner shall be submitted within two days. I&FC Department and BDO will submit their report along with proposed action plan to the Court Commissioners within a month.





2. Bajitpur Thakran

(a) Kh. No. 76/8 (04-14)

The water body belongs to BDO. The boundary wall exists on the water body. However, the water body needs clearing which should be done immediately and not later than 20 days from today. The report be submitted to the Court Commissioners within 30 days from today itself.



3. Nangal Thakran

(a) Khasra No. 92 (23-8)

The water body belongs to BDO. It is wet. However, the same requires clearing which should be done immediately and forthwith and the process of cleaning should be completed within a month. Report along with the photographs be submitted to the Court Commissioners immediately thereafter.





(b) Kh. No. 87 (9-7)

It belongs to BDO. It is wet and has clean water.





(c) Khasra No. 73 (9-15)

The water body belongs to BDO. It is in a pathetic condition besides sewerage flowing into the water body. It is also being used as dumping yard. The Court Commissioners recall that it was almost in the same conditions when the Court Commissioners had last visited the water body in 2008. Almost 11 years have passed by, but no steps have been taken by the authorities till date for revival/managing the same. Explanation needs to be called from the erring officers. Let the Chief Secretary take action in this regard.

We feel that steps should be taken to stop the sewerage immediately as also no dumping should be permitted hereafter. BDO to coordinate with the concerned authorities for taking appropriate action. A report/proposed action plan be submitted to the Court Commissioners within a month.





(d) Khasra No. 81(14-12)

It belongs to BDO. Meeting in the chamber of Sh. V.K. Tandon, Court Commissioner (Water Bodies) at Delhi High Court on 28.02.2019 at 2:00 PM. SDM (Narela), Delhi Jal Board, North MCD and BDO should be present in the meeting.

4. Qutub Garh

(a) Khasra No. 58/8 (2-8), 13(3-16) Total area (6-4)

The water body belongs to BDO. The water body is not protected from any angle. It is reported that file for sanctioning the project as submitted by I&FC department is pending in PDRD. None from the BDO present. BDO should take immediate steps and coordinate with PDRD and a report to that effect along with earlier communications be submitted to the Court Commissioners on 28.02.2019 at 2.00 P.M. at 404, Lawyers' Chambers, Block No.1, Delhi High Court. BDO would also inform PWRD regarding the said meeting and request them to be present in the said meeting. In the meantime, DGPS will also intimate PDRD regarding the meeting scheduled for 28.02.2019.





(b) Khasra No. 107/2 (11-13)

The water body belongs to BDO. Neither the revenue department nor BDO staff/representative is present/available to clarify the exact area and construction at site. Even demarcation report is not available. None of the direction as communicated earlier has been complied with. In such a scenario, BDO/revenue and I&FC department to submit proposed action plan along with demarcation and other records on 28.2.2019 at 2.00 P.M. at 404, Lawyers' Chambers, Block No.1, Delhi High Court.





5. Punjab Khore

(a) Khasra No. 1340, 1341, 1342, 1343 Total area (7-1)

The water body belongs to BDO. A park/community centre and a Mandir exists at site. The park is barren. Since construction has been carried out and a Mandir/community centre has been constructed, the department should take measures for at least installing a rain water harvesting system which will energies the ground water.





(b) Khasra No. 515 (19-17)

The water body belongs to BDO. It is dry. It is expected that before rains, steps to clean water body will be undertaken by the authorities. The authorities should submit a report along with photographs after doing the needful.





11. Junti

(a) Khasra No. 225 (29-7)

It belongs to BDO. Natural water body. It is wet.
