



It is dry water body of BDO. Community centre exist on the water body area. Court Commissioner directed BDO to clean the catchment area and install rain water harvesting system.







Court Commissioner found that lot of garbage still lying in the johar despite clear direction of Hon'ble High Court. Court Commissioner directed to Sh. Brij Kishore, AE, MCD to convey the direction to the sanitation deptt. immediately. Gargabe bin be shifted immediately outside the johar area. Further I&FC is required to put barriers on both the entry point in order to avoid entry of trolleys/trucks carrying malba to avoid the same being dumped in the water body. Nobody is present from Delhi Jal Board.
