### MINUTES OF MEETING OF SITE INSPECTION HELD ON 23.12.2017 BY THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT

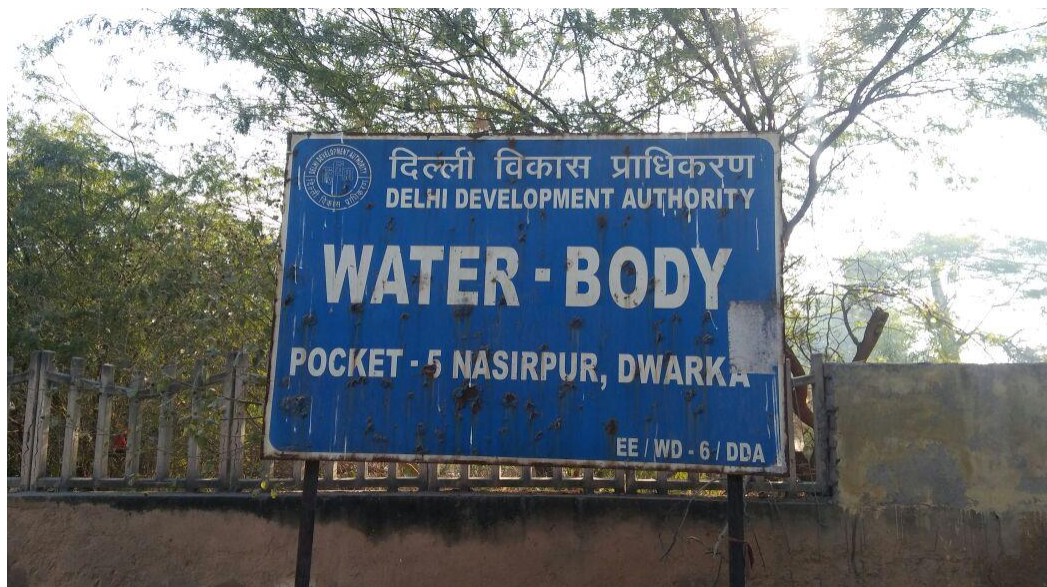
#### 1. Dhaula Kuan (5.89 Hactare)

It is a Natural Water Body. The inlet of the water has been blocked by the construction of Delhi Metro. It is reported that before the inlet was blocked the Water Body had good amount of Water Flowing in from National Highway. Meeting be called alongwith NHAI, DDA and Delhi Metro on 10.01.2018 at 3.00 O.M. at 404, Lawyers Chamber, Block 1, Delhi High Court, New Delhi.



**2. Nasirpur (Kh. No. 109 (Area- 6782 Sq. Mtr.) (12-14) out of 40 Bigha area)**

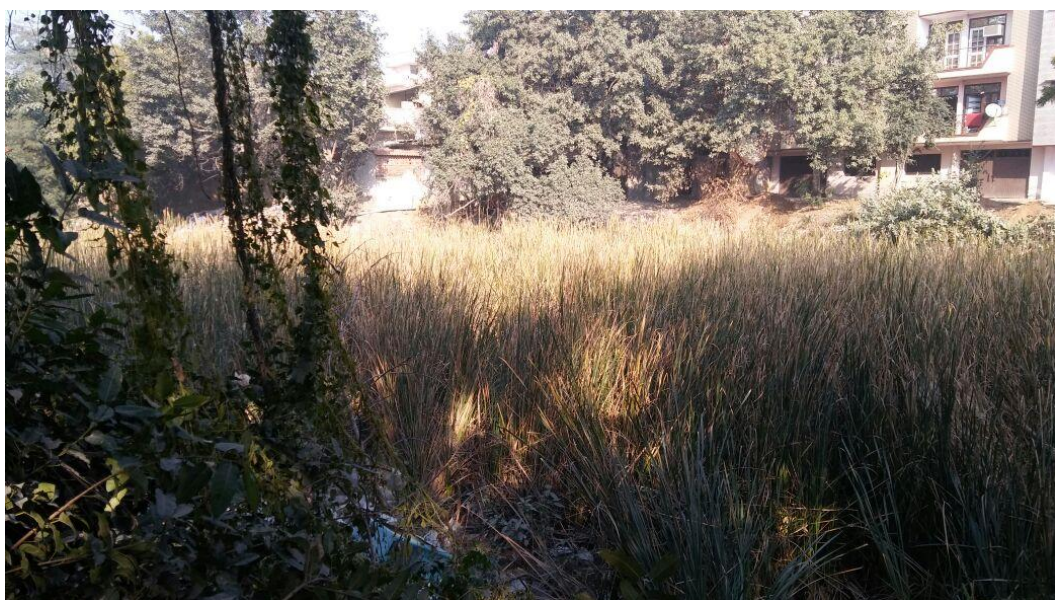
Despite information no one is present on behalf of DDA. Villagers present indicate that the water body has been made deserted and no maintenance has been carried out by DDA and whatever maintenance is being carried out it is carried out by villagers only. Explanation be called from the concerned officers. Action Taken Report be submitted on 10.01.2018 at 3.00 P.M. at 404, 404, Lawyers Chamber, Block 1, Delhi High Court, New Delhi. A responsible officer with complete knowledge should attend the meeting.





**3. Nasirpur, Khasra No. 612 (13-19)**

The Water Body is in pathetic condition. It is under encroachments having paper boards industry. Despite information, none is present on behalf of DDA. It is quite apparent that DDA wanted to frustrate our visit. Explanation be called from concerned officers. Action Taken Report be submitted on 10.01.2018 at 3.00 P.M. at 404, 404, Lawyers Chamber, Block 1, Delhi High Court, New Delhi. A responsible officer with complete knowledge should attend the meeting.





**4. Khar Khari, Khasra No. 50 (20-18)**

We found construction, material and some unauthorized construction on site. Unauthorized construction should be stopped and construction material be removed. Two numbers of RWH system was seen. The Storm Water Drain was found carrying sullage. Delhi Jal Board officials informed that construction of STP was in process. Action Taken Report be submitted by Revenue and Delhi Jal Board on 10.01.2018 at 3.00 P.M. at 404, 404, Lawyers Chamber, Block 1, Delhi High Court, New Delhi. A responsible officer with complete knowledge should attend the meeting.









5. **Sarangpur, Khasra No. 71 (8-16)**

Water Body was full of Sullage. Delhi Jal Board states land has been allotted for STP and boundary wall has also been constructed. By 2019 STP will be operated and no sewage would be flown in to the water body. Authorities should also take steps for processing Rain Water by construction catchments.



6. **Samaspur Khalsa, (Khasra No. 36/67(15-12))**

Water Body was full of Sullage. Delhi Jal Board states land has been allotted for STP and boundary wall has also been constructed. By 2019 STP will be operated and no sewage would be flown in to the water body. Authorities should also take steps for processing Rain Water by construction catchments.

**8. Samaspur Khalsa, (Khasra No. 17/28 (5-5))**

It is a Natural Water Body, however, it is land locked and we had to pass through fields of private persons to reach the Water Body. Efforts should be made to have a path for easy access to the Water Body. Sewage is flowing into the water body.
