HIGH COURT

1. Sahipur

(a) Khasra No. 4/28/2 (23-18)

It belongs to DDA. Revenue Deptt. indicate that marking will be done within 10 days. In order to avoid any controversy the date of marking is fixed as 09.05.2018 at 9:00 am. It was reported that the water bodies regularly claim, however, log book was made available to the Commissioner, further there was no catchment which could be found and the court commissioner was found that the clean water was flowing on the road adjacent to water body which if catchment was there could have easily been diverted into the water body. On spot we could not find any agriculture activity going on and as such the land given for agricultural purpose should be taken/reverted back.
