## **ORDER**

Conservation of Najafgarh Jheel is subject of Hon'ble NGT OA No. 153/2014, Indian National Trust for Art & Cultural Heritage Vs. Govt. of NCT of Delhi & Ors. The action points in Environment Management Plan (EMP) has been converted into an action plan which include constitution of Najafgarh Wetland Committee. Accordingly, a Najafgarh Wetland Committee with the following composition to create an effective institutional mechanism at district level to expedite protection and restoration of Najafgarh Jheel in a time bound manner within a statutory framework of Wetland Rules, 2017 for conservation and sustainable management of wetlands is hereby formed:

The terms of reference of the above Committee will be:-

- 1. To oversee compliance with extant regulations;
- 2. To coordinate formulation of integrated management plan and implementation strategy
- 3. To establish and maintain an integrated wetland inventory, assessment and monitoring system
- 4. To review development plans concerning the wetlands and its zone of influence, and making recommendations for preventing adverse ecological change
- 5. Communication and outreach on wetland values and functions
- 6. To promote long term management-oriented multidisciplinary research to support wetland conservation and wise use,
- 7. Habitat restoration for enhanced ecological function

Representatives of other departments may be inducted as and when necessary.
