Dirty/sewage water was present in the water body from adjacent colonies. AE (ND-8), Rohini Zone, DDA informed that the estimate for revival of water body will be prepared within 15 days, tendering will be done in 45 days, construction will be completed within 3 months. Court Commissioner directed that work completed on urgent basis. Next visit is scheduled for April' 2016 approximately. Delhi Jal Board was asked to find out solution to stop sewage entry in water body.
