The Technical Committee will consist of the following members:-

The terms of reference of the Technical Committee is as follows:-

1. Technical Committee shall review the Brief Documents, Management plans of Wetlands prepared by concerned Departments and advise on any technical matter referred by the Wetland Authority.
2. The Technical Committee shall submit its recommendations keeping Wetlands (Conservation and Management) Rules, 2017 notified by Govt. of India in mind and shall clearly list out activities to be prohibited or to be regulated for wetlands and its zone of influence separately.
3. The Technical Committee shall consider the matters as per the provisions contained in the Wetlands (Conservation and Management) Rules, 2017 as amended from time to time.

The Committee shall meet at least once in every quarter to perform their functions.

This issues with the approval of Hon'ble Minister, Environment and Forest.
