### MINUTES OF THE MEETING

**Minutes of the Meeting held at 3.30 PM on 10<sup>th</sup> February, 2015 under the chairmanship of Chief Secretary, Delhi, with reference NGT Order dated 13-01-2015**

1. Secretary (E & F) has informed that meeting of Principal Committee, formed by NGT to monitor time bound implementation of directions contained in its order, was held on 05-02-2015 in MoEF & CC, Govt. of India, All the concerned Departments attended the meeting. Secretary (E & F) attended the said meeting on behalf of CS. Minutes of the Meeting are awaited.
2. Secretary (E & F) emphasized on the need of finalizing and submitting the Action Plan on the directions issued by NGT within one months of the order i.e. 13-02-2015 to the Principal Committee.
3. Chief Secretary directed all the Head of Departments and Agencies concerned of Govt. of NCT of Delhi to submit the Action Plan on the directions of the NGT in its order on or before 13-02-2015.
4. Chief Secretary further directed the representatives of Departments/Agencies attending the meeting to initiate and identify specific action points, assumptions, limitations and possibilities of completion of each activity within a specific time frame involving financial implications without further delay.
5. He advised that in case Departments face difficulties with regards to execution on the directions issued by NGT, they must work out possible solutions, and in case of unavoidable circumstances in finalizing and submitting the Action Plan in time, Departments should seek time for the same, by filing on affidavit with NGT.
6. Chief Secretary opined that views of Revenue Department be taken for determining ownership/cultivation rights in river flood plains which changes during floods.
7. Secretary (E & F) informed that the this issue needs to be anchored in Urban Development Department as the officials/Department which are members of Principal Committee falls under administrative control of Urban Development Department. CS desired that a separate note in this regard be put up for consideration.
