1.1 The work is estimated to cost Rs. 16,00,000/- for procurement of Medicinal Herbal Plants. This estimate, however, is given merely as rough guide.

Criteria of eligibility for submission of tender documents.

- 1.2 Intending tenderer is eligible to submit the offer provided he has definite proof from the appropriate authority which shall be to the satisfaction of the competent authority, having satisfactorily completed similar works of magnitude specified below:-
 - 1.2.1 Three similar works each of value not less than Rs. 6 Lakh or two similar works each of value not less than Rs. 9 Lakh or one similar work of value not less than Rs. 12 Lakh in last 7 years ending last day of the month previous to the one in which the tenders are invited (certificate thereof be uploaded).
 - Similar works shall mean supply of plants.
 - 1.2.2 The tenderer would undertake and confirm that eligible similar work (s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of the Department, then the tenderer shall be debarred for tendering in future forever also, if such violation comes to the notice of the Department before start of work, C.E.O., DPGS shall be free to forfeit the entire amount of Earnest Money Deposit/Performance guarantee.

- 3. The earnest money will be forfeited in following conditions:-
 - 3.2 If at any stage any of the information/declaration given by the bidder is found false.
 - 3.3 If a bidder withdraws his bid during the period of bid validity specified in the tender's terms & conditions.
 - 3.4 In case of any lapse/default in honoring the terms & conditions at any stage after submitting the e-tender.

- 6. In addition to the performance guarantee that the contractor is required to deposit as per condition no. 3 above, a sum @2.5% of the gross amount of the bill shall be deducted from each running bill as well as final bill of the contractor till the sum along with the sum already deposited as earnest money amounts to security deposit @ 5% of the tendered amount of the work. The said security deposit shall be refunded after defect liability period of six months is over.
- 7. Intending tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders, the means of access to site.
- **8.** The competent authority does not bind itself to accept the lowest or any other tender and reserve to itself the authority to reject any or all the tenders received without the assignment of any reason.
- 9. All tenders in which any of the prescribed condition is not fulfilled or any conditions including that of conditional rebate is put forth by the bidders shall be summarily rejected.
- 10. Canvassing whether directly or indirectly in connection with tenders is strictly prohibited and the tenders submitted by the contractor who resort to canvassing will be liable to rejection.
- 11. The competent authority reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 12. The tender for the work shall remain open for acceptance for a period of 90 days from the date of opening tenders/90 days from the date of opening of financial bids in case tenders are invited on 2/3 bids system. If any tenderer withdraw his tenders before the said period or issue of letter of acceptance whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the govt. shall without prejudice to any other right or remedy, be at liberty to forfeit 50% of the earnest money. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.
